### Abstract Submission Guidelines:

- The Abstracts can be submitted for oral and poster presentations, kindly specify whether you are submitting your abstract for oral or poster presentation
- The abstract submitted should be original and not previously presented in any national conferences
- No changes in the abstract contents and the authorship will be allowed after the final submission. If you wish to withdraw your abstract after final date, you must inform the Monitoring & Evaluation and Health information system General Directorate of MoPH through e-mail only ([ehis.moph@gmail.com](mailto:ehis.moph@gmail.com))
- Abstracts must be submitted in English only
- Use "Times Roman" 12 font size and single line spacing for the abstract text.
- Please check the spelling and grammar carefully
- Abstracts must not exceed more than 350 words, excluding title, authors, affiliations, spaces, title notes, and footnotes
- Abstracts will be published in the Abstract Book and the oral presenters will be awarded
